

# POP.VIP Spotify eGift Card Giveaway

## Terms and Conditions

**Last Update: 3 January 2025, Version 1.2**

By participating in this Promotion, you agree to abide by these Terms and Conditions set out by the Organizers whose decisions are final and binding in all respects.

### 1. About the Promotion

The “POPG Spotify eGift Card Giveaway” promotion rewards eligible POP.VIP members for participating in the POP.VIP Save program. By saving a minimum of 1,000 \$POPG for at least one month on the platform, participants have a chance to receive a Spotify eGift Card (1-Month Key).

This Promotion **is not cumulative with other active promotions**. Each saving event will be considered for one (1) promotion only.

Participants will receive one (1) eGift Card for every 1,000 \$POPG saved, capped at a maximum of five (5) eGift Cards per participant. The number of eGift Cards awarded corresponds directly to the number of new saving events or the total amount of \$POPG saved (e.g., saving 3,000 \$POPG will result in three (3) eGift Cards).

Winners will need to submit their details for verification. Once confirmed, eGift Cards will be sent within two business days by email. This campaign is designed to celebrate and reward the POPG community while showcasing the benefits of the POP.VIP ecosystem.

### 2. General Provisions

#### a. Definitions and Interpretation

- **“Chatbot”** refers to the chat widget on POP.VIP.

- **“Entertainment” or “Entertainment Platform”** means the entertainment platforms, brands or names, whose eGift cards will be used in this Contest. They will include “Spotify”.
- **“eGift Cards”, “Rewards” and “Voucher”** refers to digital codes of Entertainment Platforms that will be sourced by the Organizer and sent to Participants once the participation is verified to be valid.
- **“Members”** refer to users who have signed up for an account on POP.VIP
- **“Organizers”** refers to POPG and POP.VIP collectively.
- **“Participant”** means an eligible individual who participates in the Contest in accordance with the Rules.
- **“Platform”** refers to POP.VIP
- **“POPG Token” or “\$POPG”** refers to the digital asset token used in this Promotion.
- **“POP.VIP”** means the platform on which the Promotion is conducted
- **“POP.VIP Save”** is a \$POPG savings program within POP.VIP where \$POPG is held in the POP.VIP account for an agreed period of time.
- **“Promotion”** means the contest or activity that the participant is engaging in.
- **“Save”** means the action of participating in the \$POPG savings program.
- **“Working Days”** refer to Mondays to Fridays from 9am to 6pm (GMT+8), excluding public holidays, in the countries where the operating team is based.

### 3. Description of Entertainment

This Entertainment eGift Card Giveaway offers participants the chance to receive an Entertainment Platform eGift Card when they fulfill the requirements of the Contest, These eGift Cards will be sourced from digital goods marketplaces.

Code redemption of Entertainment eGift Cards are subject to the terms and conditions set forth by the respective Entertainment Platforms and can only be redeemed in regions

where these services are available. It is the responsibility of the Participants to ensure their game servers regions are correct.

#### 4. Promotion Eligibility

This Promotion is available to POP.VIP Members who take part in POP.VIP Save, a \$POPG savings program on POP.VIP. Qualifying members of this Promotion have to save at least 1,000 \$POPG for a period of at least 1 month.

Each saving event will be considered for **one (1) promotion only** and cannot be combined with other active promotions.

This Promotion is open only for members residing in regions where the Entertainment Platforms are available and covered. It does not apply to regions where these services are not available. POPG reserves the right to verify the eligibility of participants and disqualify those from ineligible regions.

## 5. eGift Card Distribution

Eligible members in completing clause 4, are to use the Chatbot on POP.VIP to submit their information for verification by Organizers. These information include:

1. **First and Last Name** of user registered on the POP.VIP platform.
2. **Email Address** of user registered on the POP.VIP platform.
3. **Save Details (DDMMYYYY)** from the successful save of \$POPG described in clause 4.
4. **Country / Server Region** that users would like to claim their eGift Cards

Participants will receive one (1) eGift Card for every 1,000 \$POPG saved, up to a maximum of five (5) eGift cards per participant. The number of eGift Cards awarded corresponds directly to the number of new saving events or the total amount of \$POPG saved (e.g., saving 3,000 \$POPG will result in three (3) eGift Cards).

Once the information is submitted and confirmed by the Chatbot, the Organizer will take up to 48 hours or 2 working days to verify the information. The eGift Card will be sent to the email thereafter.

POPG is purchasing and offering the Entertainment Platform eGift Card from digital good marketplaces.

The Entertainment Platform eGift Card can only be redeemed on the countries and server regions covered by the respective Entertainment Platforms. It is the Participant's responsibility to ensure that the choice of eGift Card redemption and Country/Gamer Server Region is correct. There will be no reissuance of Rewards once the first eGift Card is issued to the user.

The Organizer is not responsible for any technical issues that arise during the redemption process.

## 6. Fraudulent Activity and Misuse

POPG reserves the right to disqualify any participant found to be engaging in fraudulent or abnormal behavior, such as creating multiple accounts to increase their chances of receiving the eGift Card.

If a participant is suspected of attempting to misuse, falsely claim, or resell the eGift Card, POPG reserves the right to withhold or revoke the voucher without notice. POPG reserves the right to withhold or revoke the voucher without notice and will disqualify the participant from this and any future promotions.

A fee is applicable for cancellation of POP.VIP Save event before it is due. If a participant is suspected of abusing the promotion by cancelling and initiating new Save events, POPG reserves the right to withhold or revoke the voucher without notice.

#### **7. Finality of Digital Code Delivery**

The delivery of digital codes via email to the participant's registered email address is deemed final and binding. This delivery constitutes the full and complete fulfillment of the promotion by the organizers. POPG will not be responsible for any claims of non-receipt or misuse once the digital code has been sent. Participants are advised to ensure their email address is accurate and secure.

This Promotion is not affiliated with, sponsored by, or endorsed by the Entertainment Platforms. The use of their names, logos, or trademarks is for identification purposes only, and all rights belong to their respective owners.
